## **Definition of An Independent Director**

An independent director is a director who does not manage the Company or any of its subsidiaries, is independent from management and major shareholders, and has no business dealings with the Company, which may compromise our interests and/or the shareholders' interests.

The main qualifications of an independent director include:

- 1. They must not hold more than 5.0 percent, including shares held by a related person, of the issued shares of the Company or an affiliated, associated, or related company. To act as a member of the Audit Committee, the ownership restriction must not exceed 0.5 percent.
- 2. They must not be involved in the day-to-day management or be an advisor who receives a salary from the Company or an affiliated, associated, or related company, or from any of our major shareholders.
- 3. They must be free of any present, direct or indirect, financial or other interests in the management and business of the Company or its subsidiaries, associated or related companies, or major shareholders.
- 4. They must not be related to, or be a relative of any executive director, executive officer, or major shareholder.
- 5. They must not act as a nominee or representative of any director, major shareholder or group of shareholders, or are a relative of any major shareholder or group of shareholders.
- 6. They must carry out their duties and exercise their judgement without being influenced by executive directors or our major shareholders, including any related persons or relatives.

The shareholding restrictions of an independent director follow the minimum requirements of the SEC or SET, in which an independent director must hold no more than 5.0 percent of the total voting shares of the company. The following table confirms that all proposed individuals meet the qualifications of an independent director.
