The Board of Directors has considered determining the Directors' remuneration to be in line with the Company's performance and the roles and responsibilities of each member of the Board of Directors to be in an appropriate level comparable to the market and the same industry. The Board of Directors has an opinion to propose the shareholders to approve the remunerations in the form of monthly standard fee, meeting allowance for directors and members of sub-committees and bonus for the year 2019 at the total amount of not exceeding Baht 10 (ten) million which is the same rate as the year 2018 and authorized the Board of Directors to allocate the remunerations to directors and members of sub-committee as deemed appropriate.
